



2019 Wentworth by the Sea Marina Striped Bass Tournament for Kids

Sunday, June 23, 2019

TOURNAMENT RULES

ELIGIBILITY:

- 8-16 years.
- A separate entry must be completed for each angler and submitted on line or by mail no later than June 18th.
- Each angler under 12 must be accompanied by a parent/guardian during the tournament.

REGISTRATION:

- Wentworth Marina Docks
- Saturday, June 22nd** between 10:00 am - 3:00 pm.
- Each angler must pick up credentials, meet with fish & game representatives & receive their angler bag.

TOURNAMENT BEGINS:

- Sunrise or 7am
- The tournament vessel will leave Wentworth Marina A Dock promptly at 7:30am.
- Each angler must wear the Tournament ID Badge.
- Anglers under 12 years must wear life vest on all floating docks and boats.

SPECIES:

METHODS:

Each angler must cast, hook and land the fish without the aid of another person.

- (except if the fish is netted at the boat or shore)*
- All Striped Bass should be released in a careful and responsible manner.
- Only one Mackerel can be entered in the tournament.

FEDERAL RULES: It is illegal to fish for, harvest, possess or retain Striped Bass in Federal Waters. Federal waters are defined by all waters more than three miles from any land mass.

LOCAL RULES: Each angler agrees that he/she has no right to contest actions of the Tournament Committee, or make claim (s) against the Committee. Each contestant enters the Tournament at his/her own risk. The Committee may disqualify any person or persons who violate the Tournament rules, falsify information, act in any unsportsmanlike manner. Committee members children are eligible to participate, tournament judge's children are not.

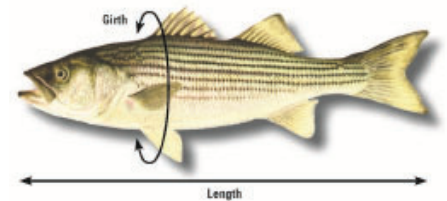
CHECK-IN:

- at Wentworth Marina Judges Station
- Lines out of the water by 11:30am
- Judging begins at 11:30 and ends promptly at 1:00pm
- Anglers must be present and on time for check-in.

**EACH ANGLER CAN ONLY ENTER ONE CATEGORY AND MUST DECLARE SPECIES TO JUDGES
TIES WILL BE BROKEN BY EARLIEST CHECK-IN AS DETERMINED BY THE TOURNAMENT JUDGES**

STRIPED BASS: *by length*

- Fish must be measured using special Tournament Tape supplied at registration.
- Photo must show the total length of the fish, with tape on top of fish.
 - If multiple photos are required be sure to include overlapping measurements.
- Girth of fish must be measured with tape around largest part of fish.
- Photos may be email to: ScottEGuyer@gmail.com or brought to judges station.
- Any photo which does not show the total fish will be disqualified.



MACKEREL: *by weight*

- Only one Mackerel per Angler can be brought to Judge's station in plastic bag supplied at registration.
- Winners will be determined by weight on the Judge's official scales.
